- Gifts will be accounted for using generally accepted accounting principles, which will provide consistent, timely, and accurate reporting of all gifts into the University's official financial record.

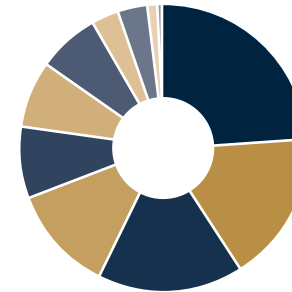

## Shakespeare at Notre Dame

In 2016, thanks in part to the generosity of the John '57 and Susan McMeel family, Notre Dame joined the world in commemorating the 400th anniversary of William Shakespeare's death by presenting an exciting array of exhibits, conferences, and performances. In addition to hosting the annual conferences for the Shakespeare Theatre Association and Shakespeare in Prisons Network, Shakespeare at Notre Dame worked jointly with the Hesburgh Libraries to welcome a touring copy of the 1623 First Folio, the book that introduced the world to William Shakespeare. Longtime supporters of Shakespeare at Notre Dame, the McMeel family established the John and Susan McMeel Family Endowment for Excellence and the McMeel Family Professor of Shakespeare Studies to provide opportunities for students to further engage in the scholarship and performance of the Bard's work. John is co-founder and chairman of Andrews McMeel Universal.

## McCourtney Hall

Notre Dame celebrated the opening of a new home for collaborative research in science and engineering: McCourtney Hall. Named in honor of Ted '60 and Tracy McCourtney, this state-of-the-art research facility is designed to encourage cross-disciplinary investigation with 100,000 square feet of open laboratories, multi-functional rooms, and office spaces that place scientists and engineers side by side. McCourtney Hall promises to foster research on the most pressing issues of our day, from resource sustainability to cancer therapies. "Supporting advancements in science, technology, and engineering has been central to my career in venture capital," says Ted McCourtney, a University Trustee Emeritus. "Notre Dame is making tremendous strides forward in this area, and Tracy and I are delighted to play a role in further supporting that effort."

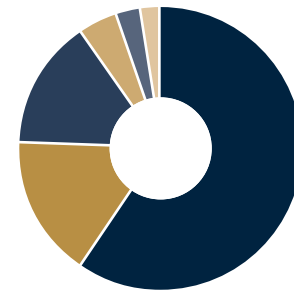

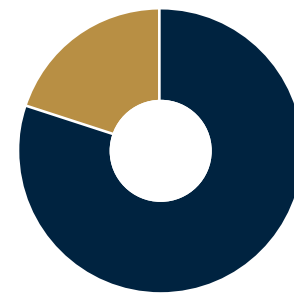

## The Ryan Winningham Family Scholarship and the Ryan Winningham Family Law Fellowship

Casey Ryan '93, '96 J.D. and Kris Winningham '93, '94 MBA love Notre Dame, but the married Double Domers admit tuition caused them anxiety as undergrads. "We set up our scholarships to make sure students don't have to go through that stress or count on luck to graduate." Winningham, nicknamed "Hoosier" at Notre Dame, incredibly relied on prize money won during basketball halftime shooting competitions to pay off his tuition balances—twice! Ryan, now Partner and Global Head of Legal Personnel at her law firm, almost did not attend Notre Dame Law School due to the cost until a life-changing, chance encounter with a generous University benefactor led to unexpected funding. Now Ryan and Winningham are giving back to help remove financial obstacles (and the need for luck) for current and future students through the Ryan Winningham Family Scholarship and the Ryan Winningham Family Law Fellowship.

Chapekar Ph.D. Endowed Fellowship for Cancer Research at Notre Dame and the Harper Cancer Research Institute. This fellowship provides graduate researchers with the opportunity to continue Chapekar's important work, and ensures that her spirit lives on in their discoveries toward ultimately finding a cure.

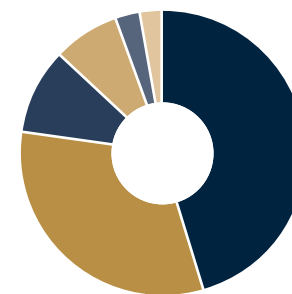

On April 24-25, 2016, the third annual Notre Dame Day was held, proving to be a day of celebration, unprecedented support, and remarkable Notre Dame stories. "The University has buildings, grounds, and many accomplishments, but in the end, it is no more or less than the people who make it up—students, faculty, staff, alumni, and friends. The spirit of these people is best expressed in stories," says Rev. John I. Jenkins, C.S.C., University president. These stories were highlighted in 207 interviews conducted over 29 hours of live Notre Dame Day broadcasting. 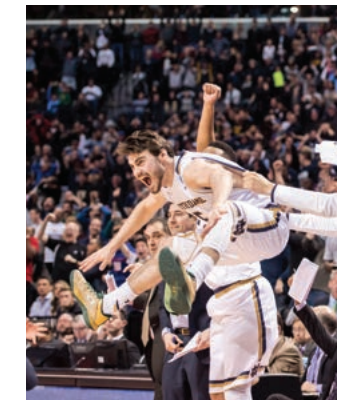

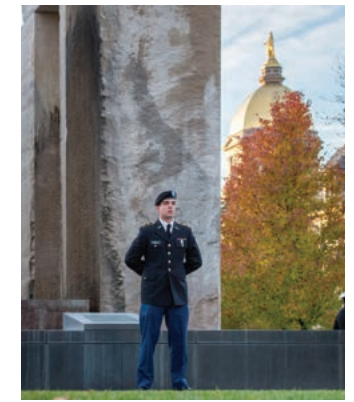

## Rockne Heritage Fund

The Rockne Heritage Fund makes the dream of wearing blue and gold a reality for Notre Dame student-athletes. Over the course of the 2015-16 academic year, the impact of more than 2,000 benefactors was celebrated. Touching the lives of 740 athletes in all 26 varsity programs, this support helped to provide scholarships, the latest in personal monitoring devices, sports medicine recovery tools, and targeted programming. This year, Rockne contributors helped to shape the Notre Dame student-athlete experience both on and off the field, propelling the Fighting Irish to succeed in competition, the classroom, and life beyond campus.

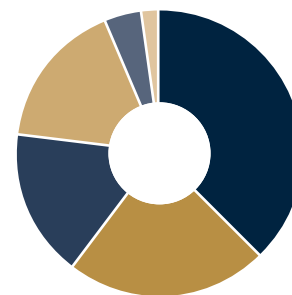

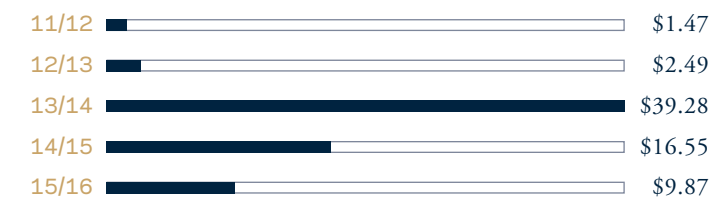


## Archer Family Endowment for Undergraduate Internships

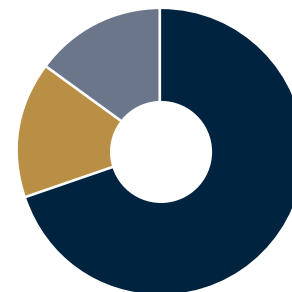

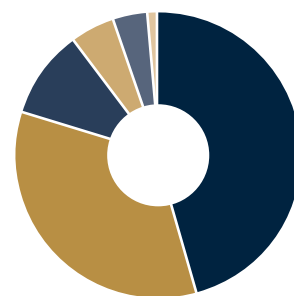
# Planned Giving

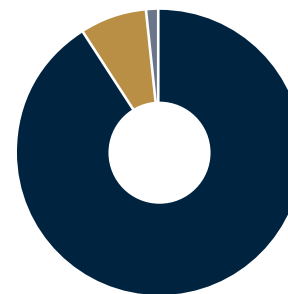


## Paul and Ruth D'Antonio Scholarship Fund

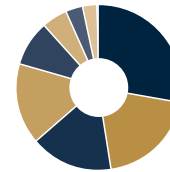

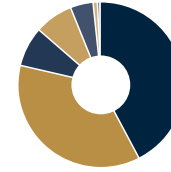

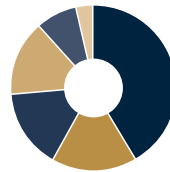

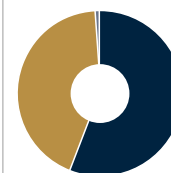
